Hello USWT Friends:

We are entering the final couple of months of our year. To me it is not coming to an end, but I am looking to this as the start of a new era for Women of Today. We have recently turned a corner with membership. We are working on a fresh new logo, and then starting on rebranding. This organization is looking for new ways to get the word out about what Women of Today has to offer. We are sharing our "Why" with others and hopefully all of us are on board with sharing this awesome group with as many people as we can. I look forward to continuing to INSPIRE as many of you as I can and to encouraging all of you to look for ways to INSPIRE new people.

I am also looking for ways to continue to help each state and chapter. I have been asking our State Presidents what they need help with. The most common issue that seems to come up, other than recruiting new leaders, is dealing with members who are causing friction in the chapters and states. It amazes me how many of us are dealing with this problem. I have been asked for advice from not only many of the state presidents but also from individual chapters. This is such a difficult and touchy issue to deal with. Do you kick someone out of the organization? Do you strip them of an officer position? Do you just ignore the issue and just do your best to keep the chapter or state together? There really is no easy answer to this, and each situation is different. I received the following from an anonymous member. I thought it was very well written and I think most of us are either going through this or have gone through it. Please read this and think about your chapter or state, and if you are dealing with a "bad seed," how are you handling it? Are you handling it or just letting it fester? There is a danger in just ignoring the problem. If anything, reading this helps us realize we are not alone in dealing with this problem.

The "Bad Seed". What is it? Who is it? Chances are you know this person, but you probably didn't recognize the danger when you first saw it. The Bad Seed is the greatest membership destroyer out there. But what is a "Bad Seed"? And, you ask, how do you know you've got one in your chapter?

If you'd like an answer to that question, just ask yourselves a few simple questions:

- 1) Do meetings seem to be less fun than they used to be?
- 2) When you're at a meeting, do you sense an air of tension in the room?
- 3) Are you experiencing more absences at your meetings lately?
- 4) Are fewer members joining in on your chapter's discussions and/or shying away from volunteering to participate in projects?
- 5) Do you continue to have members failing to renew without any obvious reason?

If you are experiencing one or more of these symptoms, it's fairly likely you're suffering from the "Bad Seed Syndrome."

Consider how the "Bad Seed" is affecting your chapter:

1) It's the member who tells you what you can and cannot do.

"That's not the way we've done it before", or "We always do it this way" or "That's not following the Bylaws (or Policies)"

- 2) It might be the member who volunteers to do everything and then doesn't follow through on anything. *Not very helpful and leaves other members left "hanging"*.
- 3) It's the member who doesn't volunteer to participate in projects, but feels comfortable criticizing or complaining about the way things are being done in the chapter. *Yikes!*
- 4) It's the member who pushes through her own agenda without giving other members the opportunity to have their own input. For whatever reason, she has decided it's her job to control the chapter and other members by trying to enforce her will upon all facets of the group. A definite chapter killer, for sure.

Sound familiar to you? Here's a couple more: "We are going to make a contribution to....(or making a decision for the chapter without a supporting vote)" "If you don't know your (officer) position then you shouldn't have the job". (Not very helpful when it's time to elect new officers.) "We should be voting on (such & such), but you already know that." Could that be any more condescending?

We could go on...and on! The taking over of a chapter can be insidious and develop over months. Before too long, your chapter is losing members because they aren't having fun anymore, the camaraderie in the group has become non-existent, and no one wants to hang around to be bullied by the Bad Seed. That's a real nightmare scenario and how does a chapter battle that?

I wish I had a miracle answer for that. But I don't. I do know that if members allow the Bad Seed to continue bullying the chapter, that chapter is probably doomed for extinction.

It's too big a job for just one person to handle. And ignoring the problem will never solve it.

It can't just be the job of the President or the person who's been a member the longest. It has to be a group effort. You have to make it clear to all members, most importantly the "Bad Seed", that kindness and respect will always be the order of the day. Bullying and negative comments hurled toward others will no longer be tolerated. And all members must have the courage stand behind these ideals.

I would agree that the best way to handle a bully is to stand up to them, and certainly the entire group standing up to this person is even better. But you have to be careful. Not everyone will view the person as a bully. You can end up dividing the group with an us versus them mentality. I believe the first step needs to be open and honest communication. Maybe try talking to the Bad Seed, or Debbie Downer, or Gossipy Gail, or whoever the problem is, one-on-one or maybe two-on-one first. See if you can get them to see that their behavior or attitude is having a negative affect on the group. Ask them if there is something they want to see improved. Speak in "I" and "We" terms. For example "We are concerned about losing members due to friction within the group." Or "I feel hurt when you question how I run a project in front of everyone."

Sometimes a member's behavior may be beyond just having a talk. For example your treasurer is taking money or a secretary never has the minutes done. You may want to consider having procedures to follow in your policies and bylaws to deal with officers, especially who might be committing a dereliction of duties. You may have to terminate someone from a position, and it is best to have something in place before you get to that point. We all hope we never have to go this far, but it is much easier if you have a procedure in place ahead of time.

Ultimately, one way or another, you need to deal with the problem member. Start with trying to smooth things over and coming to a compromise, by open communication. If that gets you nowhere, consider having your executive committee confront the problem. If the problem persists you may need to take more drastic action. But kicking someone out should be a last resort, and may have lasting repercussions. I wish I had a magical easy answer, but I do not. We are an organization of people, and we are all individuals with different motivations and personalities. Remember your "why" and stay positive. You have lots of support out here and people who will listen and try to offer advice.

Let's finish the year strong and continue to grow as an organization and as individuals.



Official Notice of Proposed Bylaw and Policy Changes

A review meeting was held on February 11th at 10:00 AM. Action items coming from the review include minor spelling and spacing issues, 10 suggested policy changes, and 6 suggested Bylaw changes which all passed through the Future Directions Committee and are noted below. Policy motions will be voted on at the Year-End Board of Directors Meeting. Bylaw changes require 45 days written notice to membership and have a 2/3 majority vote for a motion to pass. They will be voted on at the Year-End Business Meeting.

Proposed USWT Bylaws to be voted on at the Year-End Business Meeting

- I move in ARTICLE IV.6.B.1. to replace "June" with "September" and remove "incoming", where it will now read "Bids of the Mid-Year Meeting shall be submitted by a chapter/district/regions/state to the President and Chairman of the Board to be received no later than September 1.
- I move ARTICLE VII.1. to replace "appointment" with "election", where it will now read "The officers of this corporation shall be elected or appointed for a term of one (1) year which begins immediately following the Elections Meeting at the Annual Meeting. They shall not be eligible for election to the same office until a one (1) year period has elapsed."
- I move in ARTICLE VIII.1 we replace "a mail" with "an email", where it will now read "Any U.S. Women of Today Officer, Director or Program Manager may be relieved of her/his position for failure to fulfill the duties as prescribed in these bylaws and policies. Removal will require a two-thirds (2/3) vote of the Executive Committee. This vote may be taken at a National Meeting or may consist of an email vote conducted by the U.S. Women of Today President.
- I move in ARTICLE X.12. we replace "Audit" with "Review", where it will now read "Annual Review"
- I move in ARTICLE X.12.A we replace "audit" with "review", where it will now read "A yearly review must be completed by October 1 of each year by an outside source."
- I move in ARTICLE X.12.B we replace "audit" with "review", where it will now read "The review results must be submitted for approval to the Board of Directors at the Mid-Year Meeting."

Proposed USWT Policies to be voted on at the Year-End Board of Directors Meeting

- I move in POLICY 2.1.C. we add "letter of state support" after Intent to bid, and remove "Past National Presidents" after excluding, where it will now read "Intent to Bid, letter of state support and plan of action for program manager positions shall be submitted to the Chairman of the Board no later than Wednesday prior to the Annual Convention. The bids will be presented by the bidder or their representative (excluding, current National Officers, Program managers and Directors) in a five (5) minute oral presentation at the Annual Convention to the outgoing Board of Directors. Bids approved by a majority of the entire outgoing Board of Directors (voting and non-voting) will be for a period of one (1) year effective at the Annual Convention."
- I move in POLICY 4.1. we add "letter of state support" after Intent to bid, and remove "Past National Presidents" after excluding, where it will now read "Intent to bid, letter of state support and a Plan of Action for the Director position shall be submitted to the Chairman of the Board no later than Wednesday prior to the Annual Meeting. The bids will be presented by the bidder or their representative (excluding current National Officers, Program Managers and Directors) in a five (5) minute oral presentation at the Annual Convention to the outgoing Board of Directors. Bids approved by a majority of the entire outgoing Board of Directors (voting and non-voting) will be for a period of one (1) year effective after the Annual Business Meeting."
- I move in POLICY 4.1.A we add "or emailed" after postmarked, where it will now read "If any director position is not filled at the Annual Convention a bid shall be submitted to the President and Membership Vice President postmarked or emailed on or before eight (8) days following the close of the Annual Convention. The President shall fill the vacancy by July 1 with the approval of the Executive Committee."
- I move in POLICY 4.1.B. after appointment we "add with a letter of state support, a plan of action and", where it will now read "In the event no one has bid, the President may fill the vacancy by appointment with a letter of state support, a plan of action and the approval of the Executive Committee. A consecutive term may be served by the outgoing director with the approval of the Executive Committee."
- I move in Policy 5.4. we replace "distributed" with "be made available", remove "a CD Rom or other", and remove "at the Annual Meeting" where it will now read "All manuals shall be made available to the Board of Directors and all local organizations via electronic media. All changes shall be published in a timely manner on the website."
- I move in POLICY 2.1.C.1. we add "or emailed" after postmarked, where it will now read "If any Program Manager position is not filled at the Annual Convention a bid shall be submitted to the President and Programming Vice President postmarked or emailed on or before eight (8) days following the close of the Annual Convention. The President shall fill the vacancy by July 1 with the approval of the Executive Committee."
- I move Policy 2.1.C.2. after appointment we add "with a letter of state support, a plan of action and", where it will now read "In the event no one has bid, the President may fill the vacancy by appointment with a letter of state support, a plan of action and the approval of the Executive Committee. A consecutive term may be served by the outgoing Program Manager with the approval of the Executive Committee."
- I move we add Policy 11.2.E. "If bid(s) have been approved by the Convention Committee for presentation at the Annual Meeting, no other bids may come off the floor."
- I move in Policy 12.5. we add "Debts owed are subject to Bylaw section 6." after check, where it will now read "Any returned checks incurring charges to the United States Women of Today must be paid by the maker of the check. Debts owed are subject to Bylaw section 6.
- I move in Policy 18.1. we add "and/or any other social media" after Facebook Page, where it will now read, "Any returned checks incurring charges to the United States Women of Today must be paid by the maker of the check. Debts owed are subject to Bylaw section 6."
- I move in Policy 18.1. we add "and/or any other social media" after Facebook Page, where it will now read, "The current National USWT President, Chairman of the Board, and Public Relations Director will be the administrators of the USWT Facebook Page and/or any other social media."





A NEW LEAF

To provide safe shelter to as many people as possible, the New Leaf three domestic violence shelters are spread out across the valley and over two counties (Maricopa county and Pinal county), with Autumn House located in central Mesa, Faith House located in Glendale, and CAAFA shelter located in Apache Junction. Individuals experiencing domestic violence who are in need of shelter are most often referred to our shelters by the agency's 24-hour domestic violence hotline, but referrals have also been accepted from law enforcement and other community partners. Most of A New Leaf's domestic violence shelters serve all genders and can work with families or varying sizes and needs.

Though each shelter's structure is slightly different, all residents receive basic need items (such as hygiene and clothing), meals or weekly food boxes, case management, support and educational groups, advocacy, safety planning, and emotional support. Domestic violence shelters can also assist with transportation by van or provide bus passes to help residents get to work, attend job interviews, and give them access to other resources in the community. The shelters also refer to other A New Leaf programs, such as Workforce Services, the Dorothy B. Mitchell Counseling Center, DV Heart, and MesaCAN to give residents specialized support. Residents have the opportunity to stay in a shelter for up to 120 days to work on their self-determined goals with the support and knowledge of the amazing Advocates and Case Managers who empower them on their journey.

several years, the annual Pie Auction has raised thousands of dollars for this wonderful foundation.





Greetings from Minnesota,

This issue's topic, per President Laura's request is to talk about a foundation that our state supports. The Priority Area is supported by Minnesota Women of Today members with volunteer hours, as well as in-kind and monetary donations for a period of three years. We are in the second year of working with Crescent Cove, a respite and hospice home for kids with a shortened life expectancy. Crescent Cove, in Brooklyn Center, is the only such facility in Minnesota and one of only three children's hospices in the country (the other two are in California and Arizona), while there are 4700 hospice homes for adults. This special facility is designed for children and their unique needs. The goal is to help families feel Embraced, Assured, and Celebrated. The purpose of this home is to celebrate and embrace every moment. All services and stays at Crescent Cove to kids and families are at no out-of-pocket costs thanks to the generosity of donors who make this possible. Crescent Cove opened in May of 2018. This joyful home away from home is a place where families who care for their children with life-threatening conditions to utilize for short breaks of rest, or an option beyond the hospital or home environment for compassionate, end-of-life care. Nursing professionals trained in pediatric palliative care are on site to provide daily care, meals, pain and symptom control and Crescent Cove has a network of therapists to engage kids through music, art or pet therapy, healing touch, spiritual care and hydrotherapy.

We have offered volunteer time at a Back to School event where kids could pick treats and a Holiday drivethrough where families could receive goodie bags with family memory bags, craft supplies and treats. We will also assist with putting together and delivering May Day baskets.

Hello from the great state of Nebraska!

Our state philanthropy has been Aid to Foster Children since 1960's. Our state members feel the need for our support for our foster children, as they are very special children who are often deprived mentally, physically, and emotionally.

Since 1991 we supported Nebraska Friends of Foster Children. This past year Nebraska Friends of Foster Children dissolved. Through this organization our financial support we were able to provide for items such as class rings, senior pictures, music lesson and bicycles, which brings a little sunshine to the foster child's life. This past June they decided to dissolve.

At our Fall Conference we decided to keep our state philanthropy Aid to Foster Children. We voted on supporting two foundations, they are: Camp Catch-Up Nebraska Children and Foster Care Closet.

Camp Catch-Up Nebraska children is 100% free of cost for campers. Camp Catch-Up was started by Nebraska Children and Families Foundation in 2003 to offer youth in foster care, guardianship, or adoptive placements a no-cost opportunity to spend quality time with their brothers and sisters. These kids, ages 8-19, meet up with their siblings in a relaxed and fun and summer camp environment where they can take a break from the stresses of everyday life in the foster care system.

Foster Care Closet is a journey, not a destination. With our support we are here to help support children in the *entire* foster care journey.

- We continue to provide up to 5 outfits during each season for as long as the child remains in foster care.
- We provide a quiet environment that is not open to the public to help accommodate any special needs for our child or for their caregiver
- Our foster parents schedule a time to shop so that we can offer all our focus on meeting the needs of the child.

We provide additional support resources to families navigating the road of foster care.

At our Fall Conference, we also voted on a state priority program sponsored by Fremont Area chapter. In the year of 2023-2024 we will be educating our communities on Sex Trafficking.
