## Official Notice of Proposed Bylaw Changes – Second Notice

A review meeting was held on February 2, 2024, at 10:00am CST. Action items coming from the review include minor spelling, spacing, and formatting issues. 3 suggested Bylaw changes were made and have passed through the Future Directions Committee and are noted below. Bylaw changes require 45 days written notice to membership and a 2/3 majority vote for a motion to pass. They will be voted on at the Year-End Business Meeting.

# Proposed USWT Bylaws to be voted on at the Year-End Business Meeting

- I move that in Article III, Section 1 Letter B be deleted and renumber accordingly.
- I move that in Article X, Section 6 the words President, Chairman of the Board and Treasurer be replaced by Executive Committee. Where is will then read: No State, Local Organization or Individual Member shall use the name "U.S. Women of Today" "Women of Today" or the U.S. Women of Today logo for any ways and means purpose without the prior approval of the Executive Committee.
- I move that in Article X, Section 6 that letter B be deleted.

## WORKSHEET FOR COMPLETION OF A REVIEW

As you approach the end of the Women of Today year, it is important to review your chapter's financial records. A review committee should include at least 2-3 members in good standing in the chapter. This should not include the out-going treasurer but the treasurer should be available to answer questions.

The amount of detail will depend on the size of the chapter and the amount of receipts and disbursements. A small chapter's records need not be detailed as long as you can track receipts and expenses and it is clear what project they belong to. A checkbook may be adequate for keeping your records. In a larger chapter or a chapter with a great deal of activity, a cash receipt and disbursement tracking system should be maintained by the treasurer. This can be on computer spreadsheet, bookkeeping software, or by hand. An audit report should be provided in the newsletter and/or given at a general meeting.

Generally, look at the records kept by the treasurer.  Are they easy to understand and follow?  Is there a system to track receipts/expenses by project?	Yes No Yes No

A year-end report should be completed by the outgoing treasurer. This report should be traceable and agree to the cash receipts and disbursement records. If the records are all kept in the checkbook, a worksheet may have to be prepared or the checkbook itself added up.

Other considerations:

**Steps to follow:** 

Are there reconciliations and records for any savings account?

Has the chapter liability insurance been paid if applicable?

Has money been reserved and properly documented for special uses as directed by the chapter?

Has the sales tax return been filed if required?

Is there a sales tax worksheet prepared to pass on to the incoming treasurer for projects performed between January 1st and April 30 if applicable?

Has your chapter filed its 990N postcard with the IRS?

Are there any additional items that are required by your state/chapter that need to be done?

Below is an explanation of the Buckets of Sunshine projection at Annual Convention.



The organization that the Iowa WT chapter selected for the Buckets of Sunshine for 2024 is Children & Families of Iowa.

There was a question about the Buckets of Sunshine project and why we are helping an organization in Iowa when our own state has needs.

The idea of the USWT Buckets of Sunshine Project (BOS) is to have a service campaign that the public can align to the United States Women of Today. It will allow every chapter to work towards a common goal but will also have the flexibility to adapt to each community's individual needs. Each chapter is encouraged to participate by providing Buckets of Sunshine in their community as well as in the USWT Buckets of Sunshine for the Annual Meeting.

The BOS for the Annual Meeting will be coordinated by the USWT Public Relations Director, with the approval of the Marketing Committee, USWT President, and USWT Membership Vice President. A specific program must be promoted early and especially at the mid-year convention with the information to be provided for the members to make this project a huge national success and obtain national recognition that is so well deserved. This project makes a difference in the community that our annual convention is held and to the local communities that receive these bucket(s) as well.

### **USWT Buckets of Sunshine Project History**

The United States Women of Today was formed in 1985 as a leadership training, community service, and personal enrichment organization. Since its inception the organization has raised thousands of dollars for the communities, states, and health foundations (i.e., March of Dimes, Arthritis, Leukemia, Breast Cancer Awareness, and Multiple Sclerosis) it serves. There were 18 member states in the United States Women of Today with approximately 4000 members.

At the 1996 Annual meeting the Future Directions Committee decided to create a project that would bring name recognition to the organization through public relations. After much brainstorming and idea sharing, the Buckets of Sunshine Project was selected. At the business meeting the proceeding day, the project was adopted and approved by the membership. The goal of the program is to provide "buckets" filled with products to local crisis

centers (particularly focused toward women and children). The donated items would benefit someone leaving the center and help defray expenses by starting over in a new home or apartment.

At the June 2002 Annual Meeting, the Marketing Committee decided not to associate the Buckets of Sunshine project with "Make a Difference Day." It was felt that if the two are kept separate, our communities would benefit from them both. It seems to be confusing to our members along with people in the community and it was felt that the Buckets of Sunshine was lost in the media hype of Make a Difference Day.

It is one of my job responsibilities to promote and educate the membership on the organization that was selected. If you have any questions or need information, please reach out!

I want to remind everyone that when you are out and about, share Women of Today with women you meet. Do you have a chapter brochure that you can carry in your purse or backpack ready to share? How about chapter business cards to hand out or post on community bulletin boards? If you need help designing either of the above marketing tools, just contact me and we can work on it together.

# DOMESTIC VIOLENCE AWARENESS

# Why is purple the color associated with domestic violence?

Have you ever wondered why purple is the color associated with domestic violence? According to domesticshelters.org, purple, white, and gold were used in the early 1900s when the women's suffrage movement adopted the National Women's Party's colors. The colors started in England and symbolized purity, hope, and loyalty.

The women's movement was growing momentum in the 1960s and '70s, but few people were openly talking about the injustice of domestic violence, or even knew there were shelters where women could go to find refuge from an abusive partner.

On July 9, 1978, nearly 100,000 advocates marched on the capitol in Washington, D.C. in support of equal rights. Many survivors of abuse—at the time, more commonly known as battered women—were wearing purple.

"Battered women chose purple as an evolution of the lavender from decades past," Rose M. Garrity, former board president of the **National Coalition Against Domestic Violence** (NCADV) told DomesticShelters.org, because lavender was seen as a color of royalty.

Two years later, the U.S. Congress would officially designate October as National Domestic Violence Awareness Month.


